With reference to the above cited subject, as per ref (1), A Conditional Fire Safety Recommendation was issued from Chief Fire Officer, Bangalore-East Zone, Bangalore. to the low rise educational building with compressing of ground and 4 upper floors with the height of 14.90 mtrs. at **"M/s. National Public School, Sy.No.64/1, Hebbagodi village, Attibele Hobli, Anekal Taluk, and Bangalore-560 100"** with a condition to fulfill the recommendations and compliance the same within 03 months.

As per reference (2&3) 'Fire Safety Compliance Report' was issued for the same.

With reference cited (4) above, the management of **M/s. National Public School**, had requested for renew the fire safety compliance report from our department. In this regard the above addressed educational building was re-inspected by Fire station officer, E-City Fire station, Bangalore. on 18-09-2024 and submitted the report to renew the fire safety compliance report.

Under the above circumstance the Karnataka Fire & Emergency Services Department is renewing the "**Fire Safety Compliance Report**" to at "**M/s. National Public School, Sy.No.64/1, Hebbagodi village, Attibele Hobli, Anekal Taluk, and Bangalore-560 100**" subject to proper maintenance of fire fighting installations in the good working conditions and arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.

In case the fire prevention and firefighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, Petroleum products, LPG etc. in the premises/building.

"This Fire Safety Compliance Report is valid for Only Two Years from the date of issue and it is renewable without fail".
