**SIMULTANEOUS OFFLINE AND ONLINE CLASSES PROPOSED BY THE GOVERNMENT**

(To begin shortly)

Dear Parents,

As you are aware, with the significant drop in Covid numbers, the government has asked schools to reopen. However, as per Government directives, the consent of every parent is mandatory for us to permit their ward into the school premises. Without parental consent, we will not be able to permit students to attend classes in school.

With reference to the above, we are planning on beginning hybrid classes shortly for Grades 1 to 8. Students of a class will attend school in 2 batches. Classes will be conducted in the hybrid mode, with one batch in school (roughly half the class strength) and the other batch (the remaining students of that class) attending class online, simultaneously. Each batch will attend two days of offline and two days of online classes, from Monday to Thursday. On Fridays, all students will attend classes online.

We are awaiting your consent for the above-mentioned hybrid classes, through a CONSENT FORM attached to this circular.

While all tech arrangements have been made in school for the seamless functioning of the hybrid classes, this mode of teaching could have certain disadvantages, as we need to handle both online and offline sessions simultaneously. However, we are certain that parents will extend their complete cooperation, as always, keeping in mind the difficulties of teaching in the present environment and situation.

We would like to reassure you that Covid safety protocols will be followed including use of masks, screening, social distancing, sanitizing at frequent intervals, etc. Kindly advise your ward to follow the same in the interest of the whole community. Thermal screening of students will be done by the security personnel before allowing students into the school campus.

We further bring to the attention of all parents that from our previous experience, parents tend to be negligent by sending their children to school even with mild fever, cough, cold etc. Keeping in mind the safety of all concerned students with symptoms of ill- health will be sent back home to prevent contact with others. Please do not send your ward to school if he/she shows any of the above symptoms.

We would also like to remind parents who have not paid the school fees to kindly do so immediately. As per the Supreme Court judgement, those parents with genuine difficulties due to COVID situation, in terms of loss of job/income, can approach the school authorities with proof of their position. We will extend our support to such parents and their children. Also, as per the Supreme Court judgement, schools are at liberty to take appropriate action to recover fees from parents. We are thinking of how to enforce this direction of the Supreme Court. It will be embarrassing for parents, teachers and concerned students of the children's names are notified as defaulters. We do appreciate and also request parents to extend all support and cooperation in this regard.

Looking forward to a smooth transition to the hybrid mode of classes.
